### 1. APPROVAL OF MEETING MINUTES

Motion to approve the February 20, 2020 meeting minutes. Motion carried; all voted aye.

## 2. OLD BUSINESS

## a. Middle School Update

i. Gym Floor Repair

Repair of the gym floor is scheduled for the summer. Miller Flooring will be doing the repair and the cost will be covered by a change order with Boro Construction, the general contractor.

## b. High School Update

i. Chiller Repair

The chiller was found to have multiple leaks. This needed to be repaired.

### ii. Tennis Courts

Quotes have been received for the repair of the tennis court surface due to divots occurring because of the clay coming to the surface.

## iii. Pool Level Control Valve

The current valve is in disrepair. It is difficult to regulate the water level in the filter tank. The repair was previously approved. The valve needs to be replaced.

#### iv. Athletics Equipment

The baseball scoreboard has been received, the suppliers for the pole vault pit and the softball fence are shutdown.

## c. Marlborough Update

i. Playground Replacement

There was a discussion on paring down to a single playground due to enrollment and the need to replace the existing structure.

### d. Energy Performance Contract

Data is being supplied to conduct research.

## 3. NEW BUSINESS

#### a. Closure Activities Update

Staff is checking buildings every other day to keep utilities functional. All courts, playgrounds and fields are closed.

## b. Critical Spring and Summer Projects (Attachment B)

The itemized list was divided into critical and routine. Routine is considered items like painting upkeep, carpet replacement and weeding. Critical are items such as the

completion of the punch lists for the new and renovated buildings, secure entrances and any of the projects that cause safety concerns.

- c. Upcoming Bids (Mowing, Elevator PMs, Entrances) Bids for these projects will be advertised.
- d. 4<sup>th</sup> & 5<sup>th</sup> Grade Center Parent Drop-off and Pick-up Location There have been discussions with East Greenville Borough about increased traffic causing concern. The District has met with representatives from East Greenville and will continue to discuss possible options keeping the safety of the students as the primary focus.
- e. Athletics NFHS Network Cameras
  This a school broadcast program that provides automated sports productions. This will allow remote visibility of some of our events.
- f. Indian Stadium Bill Keeny Naming Application A discussion occurred with community members calling in. There were some liability and maintenance concerns and precedents being set with this from some board members. After a lengthy discussion by Board members present and community members, the motion by the committee did not have support to move the naming onto the Board agenda.
