Revised language on Office for Safe Schools reporting, to better reflect School Code.  Added recommended language on incidents involving the
			sale of tobacco to minors by employees on school property, etc. being reported to school police, SRO, or local police department, in accordance with state law and regulations.  Removed definition of electronic cigarette and replaced with newly revised definition of nicotine delivery product, based on best practice recommendations.

			Added PSBA recommended general language on the type of documentation to be entered into a personnel file, as well as language on the Board being able to review such files, but only as required in the performance of its functions.

			Added PSBA recommended language on periodically reviewing personnel files.
			Updated/Added language on the release of information to parents regarding the qualifications of teachers and paraprofessionals in Title I schools in compliance with law.
