1. Approval of October 2020 Meeting Minutes (Attachment A)

Meeting called to order 6:05pm. Minutes from October approved.

- 2. Update on Hybrid Program at UPSD
  - a. 1:1 Device and Hybrid Technology Update- Week 2 of Hybrid Learning.

Teachers and Paraprofessionals- all working hard to meet student needs

Switched out 6th grade laptops for Chromebooks- no issues; Switched out K iPads for touch screen

Chromebooks- few bumps- working them out!

Students VERY happy to return, Teachers happy to have them back

Manageable number of students on campus daily.

More practice with tech and routines in building will help with efficiency

Jim Roth shared pictures of technology in action - UPOLA teacher, K classroom, MS classrooms- going well

b. Summer Programming

We are analyzing our data carefully with an eye on learning loss that we may see with our students. We are making data informed instructional decisions in classrooms now, but realize we will need compensatory summer programming for those who are in need. We are planning to use grant money to support a K-12 summer program. Here are the basic parameters:

- 1. ELA and Math only
- 2. Benchmark and other data will indicate which students get "invited"- it is an invite only program
- 3. It will include transportation for those who need it all free to families (grant funded)
- 4. It will run for 4 weeks (parallel with ESY) during the end of June, beginning of July.
- 5. It will be four day a week, ½ day program

#### Committee Mission Statement:

To support and enable instructional opportunities that engage students at all levels to achieve at their highest potential ensuring success in both academics and in life after graduation; resulting in a district where students want to learn, teachers want to teach, and parents/guardians want to send their children.

- 3. High School Program of Studies- Presented by Dr. Carpenter and Mrs. Bast to be placed on the full board agenda for approval in January. No new classes, few changes, summarized below:
  - 1. Business courses aligned/combined to match MCCC dual enrollment courses, older ones deleted.
  - 2. Algebra III not being offered in 21-22 according to pre-determined plan from 19-20.
  - 3. Smart Futures and Act 339 language added, as we focus on Career and College readiness 8th Grade Parent night is scheduled for February 10, 2021, hosted by Dr. Carpenter.
- 4. Review of Curriculum Review Cycle- 2020-2021 and beyond- Mrs. Bast shared the Curriculum Review Cycle created by Dr. Farina's team in 2017. It is on track, however, because of the sheer volume of courses in various subject areas, it is impossible (due to budgetary and personnel constraints) to review ALL K-12 courses in every subject area in the designated year. Slide deck has links to current curriculum writers, those scheduled for next year and the following.
- 5. Class Rank Policy & Procedures- Dr. Farina explained that Class Rank Policy, as well as Graduation Requirement policy were discussed at the Policy meeting, with recommendations to bring the conversation to the Curriculum and Instruction committee. The administration is recommending the discontinuation of class rank at UPSD because we believe it is hurting students in terms of admission to college, and/or opportunities for scholarship. Many districts locally and nationally have discontinued the process since it does more harm than good, and we would like colleges to consider the whole student, and require them to dig deeper into student information rather than a quick judgement based on class rank among many good, high performing students. We will provide a full board presentation at the February workshop, in order to share the research and plans, so that it can be discussed again at policy in March, and possibly placed on the board agenda for a first read. Tentative plan, to be confirmed.
- 6. Update on Full Day K Preparation- We ran out of time in the meeting to fully discuss this. Dr. Farina and Mrs. Bast will need to begin Kindergarten registration in March, so need to know if we will offer FDK or HDK. Knowing the budget is the deciding factor, and that isn't approved until June, we are seeking direction from the board. Dr. Drake will follow up with Mrs. Cunningham to discuss when/where to continue the discussion to allow planning to move forward.
